4. Committee Reports


- Architecture Review: Gene New is temporarily on leave due to illness, Marty Haloda will cover for him until he is better to return. Jim Syms, after years of service has resigned. Marty has asked Robbie Cleland and Lee Huggins to be part of the committee.
- Clubhouse/Common Grounds/Lakes: Marty reports that the 800 Bluegill- Bream 3-4" have been added to all the ponds. Sherri Gordy recognized, she wanted the board to know that there has been a couple that has returned often to the ponds to fish and they are not releasing them, perhaps for eating.
- Gate: Ron Baldwin reported that the committee has been working with planning how to pay for the project, perhaps in steps. They also reviewed just replacing the 2 operators, 2 longer arms and a green and red light verses a complete system. There are gathering data on all the consequences of changes to a complex system.
- Office: Sherry reported that we have plenty of lamp post panels for sale in the office, she also met with Jenkins plumbing for the drainage problems between the clubhouse and the tennis court and emailed that info to the board, plus an email a proposal from Terminix about Pest Control/Termite bond.
- RA Coordinator- Robby Cleland reported that they have gotten 19 confirmed RA's with just section 4,12 &14 needed to be committed. Marty reminded Robby that all 22 section would have to be covered for the board to continue support
- Roads and Drainage- Ron Baldwin gave general information on what the committee has been working on, basically they have a 3 part plan starting with Ditch 2 (Cypress bottom) Lynn & Scott Kaye had concerns about the easements and asked if lift stations were an option, Ron said the answer is complicated and they would consider all the issues before proceeding.
- Social- Lisa Birzer said that there were approximately 40-45 people at the Easter Egg Hunt, and that the yard sale is May 6th Sunday and Marty volunteered to have the gate up for the event.
- Welcoming- Kristen reported no new residents since the Thompsons moved in March 24th.
